The Pimlico District Heating Undertaking (PDHU) is

owned by Westminster City Council and managed by CityWest Homes. Built over 50 years ago to help combat London's air pollution, the PDHU continues to be a crucial source of clean, affordable energy in the city. The PDHU is the UK's first combined heat and power network and provides heating and hot water services to 3,256 homes, 50 commercial premises and 4 schools.

"We are very pleased to improve both the protection of our assets and the safety of those people working in their vicinity by joining LSBUD" said Chris Richardson, Head of PDHU and Energy.

Wales & West Utilities

Coming live in Q1 2017

We are delighted to announce that Wales & West Utilities will become the latest Member choosing to protect their assets through LSBUD. Wales & West Utilities transport gas through their 35,000 kilometres of pipes to 7.5 million customers in Wales and the South West of England. The area that they cover equates to 1/6th of the UK!

Wales & West Utilities' Connections Manager, Nigel Winnan, said "Membership of LSBUD gives our business an improved capability to identify planned third party works within our region that pose a risk of interference to the gas distribution network, and to be in contact with those third parties so that we jointly manage risk".

The LSBUD service for Wales & West Utilities is currently under development and we expect it to be live early in the New Year. Existing Users of the current Wales & West utilities maps will be redirected to the LSBUD system.
